Ratepayer Tyler Smith was requested to attend the Council meeting by Reeve Mark Henderson to speak to the proposed Otter Lake Road Committee and his interest in seeing a resolution to Consent Application #04/21 whereby an alternative access to the Otter Lake is being

considered. Public input and involvement are being sought in the vision of a proposed alternative access to Otter Lake. In addition, other boards and committees would be expanded to not only include Councillors but member of the public with knowledge and interest in the respective committees.

- Enhancement of the Jocelyn Landfill Committee to include ratepayers/residents who will provide recommendations to Council regarding landfill and recycling matters

Several verbal reports were provided by Council members.

The Clerk advised of a phone call from a concerned ratepayer regarding the U Line and Highway 548 and 5<sup>th</sup> Side Road intersection. In 2017, the municipality had petitioned the Ministry of Transportation about significant concerns for the driving public as through traffic on the 5<sup>th</sup> Side Road are at risk of being in an accident should west bound vehicles turning left on the 5<sup>th</sup> Side Road do not yield. Near misses and evasive action by drivers have been reported. The Clerk advised that the matter had been brought to the Ministry of Transportation's attention again and she will report back.

The Clerk included a summary of building activity for 2022. To date, building permit values total 1.2 million dollars, compared to 1.123 million in 2021. In both years, applications included three new residential units, as well as garages, outbuildings, and miscellaneous permits (decking/small additions).

The 2022 Election Accessibility Report was included for Council review. Vote by mail was the format used for the 2022 municipal election. Voter turnout summary: 2022(59%), 2018 (43%), 2014 (no election) and 2010 (64%).
