The regular meeting of Council was held on May 2, 2023 at the Jocelyn Township Office.

A. Call to order

23-068 Moved by Albert Crowder Seconded by Faye Stevens Resolved that we do call the regular meeting of Council to order at 7:00 PM. Cd.

Adoption of minutes from previous meeting

23-069 Moved by Faye Stevens Seconded by Greg Gilbertson Resolved that we do adopt the minutes of the April 4th meeting of Council as presented. Cd.

Disclosures of Conflict of Interest

Township Vouchers were presented for approval. Reeve Henderson declared a Conflict of Interest and vacated his seat for the adoption of Recreation Voucher No. 2023.03 (B) and No. 2023.04 (B) and Township Voucher No. 2023.04 (B) as his spouse is an owner of Kentvale Merchants.

B. Delegates

1. Reeve Henderson welcomed Algoma Power Inc. representatives Peggy Lund (Customer Service) and Andrea Mattioli (Vegetation Management) to the meeting. Numerous issues were highlighted, including the importance for property owners to call before digging even for tasks as simple as planting a tree or building a deck. There is no cost in obtaining such locates. This will avoid potential damage to the power infrastructure. Community attachments, such as lighting and signage on Algoma Power poles were also highlighted. The need for future infrastructure to support senior government's plans for more electric cars is being studied. Difficulties of accessing electricity ports for electric vehicles were noted given the size of the province and the distance between charging locations.

The topic of high delivery costs was again discussed. It was explained that the delivery cost includes the costs of all the infrastructure required

(substations/poles/transformers/power lines/etc.) to get the power to properties. The problem in the North is the significant kilometres to be serviced and the low number of households in comparison to larger centers. A rural subsidy has been approved by the provincial government to help offset the high delivery cost. The subsidy is only available to permanent residents as the government considers seasonal residences more of a luxury use and not used as much during the winter periods.

Ms. Mattioli addressed the work carried out by the Vegetation Management sector of Algoma Power. Vegetation control began on St. Joseph Island in the early 2000's using a six-year cycle. As time and funds permitted, crews would cut back trees and brush in incremental stages to remove the problem of tree branches disrupting power during storms and improve upon drivers' visibility for wildlife. The subsequent problem of brush growing back was discussed and the need for the difficult conversation of herbicide applications in some areas. Algoma Power will continue its efforts to assure owners that the amount and manner of application will always adhere to safe practices but also recognizes the concerns many owners have when it comes to this. Open houses are being planned to provide information to St. Joseph Island landowners regarding vegetation management and the use of herbicides. It was noted that the use of the product is permission based.

Additional information provided included the 2023 capital project schedule for Jocelyn Township. This includes pole replacement on Twining Court (17 poles) and Sterling Bay (31 poles). The reliability score card was presented for information. The average number of hours that power to a customer was interrupted is based on a 5-year rolling average. In 2017 – the average number of hours that power was interrupted was 7.68 hours – in 2021, this average was 3.61 hours. The distributor target is 7.36 hours. The average number of times per year there has been a power interruption in 2017 was 3.95 times. In 2021, the average annual outage average was 1.77. The distributor target was 3.16 times.

Regulatory applications including 2023 distribution rates were noted, as well as a new electricity pricing plan rate option referred to as "Ultra Low", available after November 1, 2023. More information can be found on the API website.

Further discussion arose regarding removal of lilac trees on the 10th Side Road at the P Line during the vegetation control process. This matter will be investigated. Reeve Henderson thanked Ms. Lund and Ms. Mattioli for their attendance.

2. Reeve Henderson welcomed Zach and Hollie Lefebvre, owners of Concession Q, Lot 9, to the meeting. They were seeking confirmation of their continued access and providing information regarding access to their property. As requested at the previous meeting, they asked to be kept informed of any plans and discussions regarding access that would affect them. It was confirmed that the municipality had no intention to prevent access to their property. Council has been seeking clarification from the

municipal counsel regarding the property identification number (PIN) of the property that is currently being used as access. There is no survey in place that confirms the exact location of that access, noted on documents that have been obtained by both parties. Mr. and Mrs. Lefebvre were thanked for attending.

1) Summer maintenance proposal with Stobie's Mechanical and Welding. Cd.

Stobie's will continue to do the spring/summer/fall maintenance work for the municipality, including patching, sign repair and installation, tree removal and other tasks as assigned. The municipality uses other contractors for tasks such as hydro axing, sweeping, and roadside cutting. Landfill work and ditching is often dependent on the availability of contractors. As noted in the previous minutes, the winter control contract ended on April 30, 2023, and we were due to go out for tender. This is typically done once every four years (ie once every term of Council).

Also included in the Clerk's report:

- Two upcoming events of Jocelyn Recreation Committee include the Maple Run/Walk on the last Sunday of May and the Gapp's Gambit (Disc Golf Event) on June 10
- Several items are in progress, including review of the fees and charges by-law, including building fees.
- To date, eight building permits have been issued six for construction projects and two for a demolition of structures.
- Several road matters were listed, including spring clean up tasks that are underway, gravel being placed on a washout on A line extension, a tentative Roads Capital Budget, and the matter of overweight vehicles being on Township roads during half loads. This matter was dealt with by Reeve Henderson.

Whereas the Township of Jocelyn and Council are committed to demonstrating good governance and greater accountability to its Code of Conduct and workplace policies;

Now therefore be it resolved:

1. That Jocelyn Council endorses Bill 5—Stopping Harassment and Abuse by Local Leaders Act, 2022 which would require the Code of Conduct for municipal Councillors and members of local boards to include a requirement to comply with workplace violence and harassment policies and permit municipalities to direct the Integrity Commissioner to apply to the court to vacate a member's seat if the Commissioner's Inquiry determines that the member has contravened this requirement.

2. That Jocelyn Council expresses its support for Bill 5 by directing the Clerk to send this motion to the Premier of Ontario; the Ontario Minister of Municipal Affairs and Housing; the Association of Municipalities of Ontario (AMO); the local Members of Parliament (MP's); the local Members of Provincial Parliament (MPP's); and FONOM.
