Peggy Lund and Dan Richards of Algoma Power were in attendance for their annual visit to update Council on matters of importance and interest. Items included the following:

- 1) API advised that Agreements with municipalities are possible to address placement of decorative items on API property (ie. power poles)
- 2) Environmental Sustainability further research on the impact of Herbicide used in the corridor maintenance
- There continue to be several community engagement opportunities including meeting with area municipal councils, road superintendents and public works, and community meetings
- 4) Affordability Funding this program is still open for applications
- 5) Emergency Management in light of the significant weather event in December there was a discussion about lessons learned from this event and consideration given to coordination of activities to manage the event
- 6) Several works projects will be completed this year and as of right now, pole replacement on the 10th Side Road from the K Line to Hilton Road is the only project on the schedule.
- 7) The Algoma Power score card was noted average number of hours that power to a customer was interrupted 7.51 hours (distributor target was 10.62 hours) and the average number of times the power to a customer was interrupted 2.19 times (distributor target was 4.46)
- 8) Regulatory applications the 2020 Distribution rates were noted they are available on the Algoma Power website http://www.algomapower.com/

The owners of Concession M, Lot 5 Part, were in attendance to discuss access to the M and N road allowance on the west side of the Hilton Road. Council agreed that they have no opposition to permitting a ratepayer to open up the road allowance for access providing certain conditions are met. This included providing a survey to ensure that any access would be located on the right of way, and to obtain all necessary permits and environmental reports that may be required from any affected Ministry.
