7. Recycling Matters

Deputy Clerk/Treasurer Peter Barness verbally presented us with the information regarding two different companies that offer services for recycling. GFL already services townships in our area with a similar set up. They suggest four six yard bins, to empty these on a bi-weekly basis, you would be looking at \$1829.00 monthly before tax. If we chose to use less bins, the cost would be less. GT Waste Systems suggests using a twenty yard bin with a lid, emptying it when we call them to do so. The cost is \$1250.00 before tax, per load emptied. Council requested additional information, in writing, so an informed, cost-effective decision can be made. Peter will gather further details and present them at the next scheduled meeting. Clerk D'Angelo can assist with presenting his findings. For the time being, notices will be posted on our website and Facebook page asking rate payers to either hold onto their items or to include them in their household bags at the landfill.
