Introduction

The Township of Jocelyn has declared its 1980 Ford 9000 Ford Fire Pumper Truck for surplus with a minimum bid value of \$5,000. The Township is accepting sealed bids to purchase the vehicle “as-is, where is”. Photos of this vehicle are shown on page 3 of this document.

Description of Surplus Asset:

Jocelyn’s 1980 Ford 9000 Fire Pumper Truck is being sold “as-is, where is”, and has the following specifications:

- Ford 9000 Detroit Diesel Motor in reasonable & working condition
- Allison Automatic Transmission
- King/Dependable fire body installed in 2000
- 1050 gallon Hale Pump, 400 gallon booster tanks
- Pumps are in working condition with several leaks in outlet valves
- One new rear fire, all other tires in reasonable condition
- Old fire hoses included
- Current mileage is at approximately 162,600 km, (subject to change)
- Vehicle has been previously rustproofed and undercoated on multiple occasions
- Recent valid mechanical completed
- One hood hinge needs repair
- Battery tender air connection
- Ladders shown in pictures are **not** included.

Purchases must be aware that this vehicle is being sold **as is, where is**, with **no warranties or guarantees** expressed or implied by the Township. Bidders acknowledge that they have had the opportunity to inspect the vehicle and accept it in its current condition, including any known or unknown defects, mechanical issues, or cosmetic imperfections. The seller makes no representations regarding the roadworthiness, safety, or fitness of the vehicle for any particular purpose. All sales are final. The buyer assumes full responsibility for any repairs, registration, and transportation upon purchase.

Deadline & Additional Details:

Sealed Tender Submissions will be received by **12:00 p.m. local time, Friday, October 24, 2025**. Late applications will be automatically disqualified. Bids must include a 10% deposit in either a cheque or cash form. Unsuccessful bidders will receive their 10% deposit back upon the tender being awarded.

In the event that an individual/firm is awarded the bid, they shall have 30 days from the date of being awarded the tender to pay the remaining balance of their bid in full, or their deposit shall be forfeited in full, and the next highest bidder shall be awarded as long as they meet the minimum bid amount.
